  - b. An advertised public hearing to consider a request by Jennifer Korge representing Gensler Architects for Special Use Permit No. 1089 (SP-1089) to allow a church use with a chapel, course rooms, and related offices in a 45,000 square-foot two-story with basement commercial building on an approximately 34,400 square-foot C-1 (Limited Commercial) zoned property.

An advertised public hearing to consider a request by One Imperial Plaza, LP for Special Use Permit No. 1090 (SP-1090) to allow a 1,187 square-foot addition to an existing 7,535 square-foot building that is part of a 160,578 square-foot exterior shopping center.
