- Crenshaw Service Road is a one-way street. Drivers are not alert and drive in the opposite direction. This is an enforcement issue and Police should be notified to monitor the matter.

March 27, 2019 Meeting Minutes

- Residents are requesting the formation of a residential permit parking district on 11th Avenue between 99th Street and Hardy Street due to the excessive number of cars parking on this street. Public Work expanded the areas 10th, 11th Ave and west of Crenshaw Service Road between Arbor Vitae St and 99th Street and Hardy Street, 99th Street between 11th Avenue and west of Crenshaw Service Road to minimize spillage of the parking problem to adjacent residential streets to avoid any spillover effect. The requested permit parking hours are twenty-four hours a day seven days a week.
- Engineering report was read and explained by the City Traffic Engineer to the public of the data findings, which showed that there is not a parking issue in this area.
- The Commission allowed the residents who attended the meeting to come forward and provide public comments on the matter.
- After review of the study and hearing public comments, the Parking and Traffic Commissions voted to deny District 5-0 parking permit.
