RECOMMENDATION:

It is recommended that the Mayor and Council Members take the following actions:

- 1. Approve Amendment No. 2 to Agreement No. SSP141811 between the County of Los Angeles Workforce Development, Aging and Community Services (County) and City of Inglewood extending the contract through June 30, 2019, to receive grant funds in the amount of \$68,512 for the provision of Care Management Services for Senior Citizens and Disabled Adults; and
- Adopt a resolution providing signatory authority to the Mayor for all documents relating to Agreement No. SSP141811 without further City Council approval.

BACKGROUND:

Since 1986, the City of Inglewood has received grant funds through the County of Los Angeles to provide care management services to elderly and disabled persons living in Inglewood, Hawthorne and Lennox. On October 18, 2013, an RFP for SSP was released and the Mayor and Council Members authorized the filing of an application with the County of Los Angeles Workforce Development, Aging and Community Service (formerly known as Los Angeles County Area Agency on Aging).

The City was successful in its bid and was awarded a four-year agreement, from July 1, 2014, through June 30, 2018. The current agreement expires June 30, 2018. In lieu of issuing a new RFP for agencies providing SSP services, the County recently notified the City that it would extend the current agreement for one year, from July 1, 2018, through June 30, 2019.

Care Management provides comprehensive assistance to eligible clients in transition of entering or returning home from a nursing home facility and to individuals and their families for the prevention of premature or inappropriate institutionalization. Units of services include intake/screening, assessment, monitoring/follow-up, reassessment, and comprehensive information on the availability of community resources. The City's Care Managers are Social Workers hired with grant funds to provide in-home services to frail and disabled persons. By performing comprehensive assessments, clients are linked to services that enable them to stay in their homes as long as possible, while monitoring their progress.

DISCUSSION:

The Amendment will allow the City to receive \$68,512 to continue to provide the aforementioned services. In addition, the County may require additional documents including exhibits and financial reports and may also require close-out and program status reports the will need to be executed by the Mayor during the term

of the agreement. The attached resolution authorizes the Mayor to execute and submit all documents, including, but not limited to, applications, agreements, amendments, payments requests and so forth, necessary for the completion of the project.

FINANCIAL/FUNDING ISSUES AND SOURCES:

The revenues from this grant will be budgeted in 220-070-7061-5273-00. This is a performance based grant, reimbursed at a \$45 per unit/hour rate of up to 2,000 units annually. Client data is entered into the County's computer system, which generates the payment to the City.

AMENDMENT TWO

This Amendment is made and entered into by and between

COUNTY OF LOS ANGELES THROUGH ITS DEPARTMENT OF WORKFORCE DEVELOPMENT, AGING AND COMMUNITY SERVICES ("County" or "WDACS")

and

City of Inglewood ("Contractor" or "Subrecipient")

Subrecipient's Business Address: One Manchester Boulevard Inglewood, CA 90301

WHEREAS, reference is made to that certain document entitled "Supportive Services Program (SSP) Contract Period July 2014 - June 2018 Contract Number SSP141811" dated July 1, 2014, and the amendments thereto (hereafter collectively referred to as "Contract" or "Subaward"); and

WHEREAS, the parties hereto have previously entered into the above referenced Subaward for the purpose of providing supportive services to Los Angeles County's older individuals and functionally impaired population; and

WHEREAS, County and Subrecipient recognize and agree that specific terms (including, but not limited to, Contract, Subaward, Contractor, Subrecipient, Subcontract, Lower Tier Subaward, Subcontractor and Lower Tier Subrecipient) are used interchangeably throughout this Amendment in order to comply with Federal, State and County regulations; and

WHEREAS, it is the intent of the parties to amend this Subaward for the following purposes: 1) extend the term of the Subaward for one (1) additional year commencing on July 1, 2018 through June 30, 2019; 2) allocate Older Americans Act (OAA) Title III B (Supportive Services and Senior Centers Program Authorized) baseline funding in the amount of \$68,512 in exchange for additional defined Program Services to be provided by Subrecipient during Fiscal Year (FY) 2018-19; and, 3) provide for the other changes set forth herein; and

WHEREAS, the Subaward provides that changes to its terms may be made in the form of a written Amendment, which is formally approved and executed by the parties.

NOW THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

- I. This Amendment shall commence on July 1, 2018 or upon execution by all parties, whichever occurs later.
- II. The title of this Subaward shall be deleted in its entirety and replaced as follows:
 - Supportive Services Program (SSP) Contract Period July 2014 June 2019 Contract Number SSP141811
- III. Paragraph 1.0 (Applicable Documents), Subparagraph 1.7 is added as follows:
 - Subrecipient shall comply with the State's terms and conditions and shall obtain the most current version of the CDA contract and any amendments thereto which are available online (on the Contracts Download Page) as follows: https://www.aging.ca.gov/Contracts Download Page/.
- IV. Paragraph 4.0 (Term of Contract), Subparagraph 4.2 is deleted in its entirety and replaced as follows:
 - 4.2 The term of this Subaward shall be extended for an additional one (1) year period commencing on July 1, 2018 through June 30, 2019, unless sooner terminated or extended, in whole or in part, as provided in this Subaward.
- V. Paragraph 5.0 (Contract Sum), Subparagraph 5.2.6 (Year 5 Maximum Annual Contract Sum Funding Source(s)) is added as follows:
 - 5.2.6 Year 5 Maximum Annual Contract Sum Funding Source(s)
 - 5.2.6.1 The Maximum Annual Contract Sum for the term of July 1, 2018 through June 30, 2019 is \$68,512 (consisting of Title III B (Supportive Services and Senior Centers Program Authorized) funds).
- VI. Paragraph 5.0 (Contract Sum), Subparagraph 5.3 (Catalog of Federal Domestic Assistance (CFDA) Program Number(s)) is deleted in its entirety and replaced as follows:

5.3 FEDERAL AWARD INFORMATION

- VII. Paragraph 8.0 (Standard Terms and Conditions), Subparagraph 8.2.1 is deleted in its entirety and replaced as follows:
 - 8.2.1 Subrecipient (that is, "Contractor") shall notify County of any pending acquisitions/mergers of its company unless otherwise legally prohibited from doing so. If Contractor is restricted from legally notifying County of pending acquisitions/mergers, then it should notify County of the actual acquisitions/mergers as soon as the law allows and provide to County the legal framework that restricted it from notifying County prior to the actual acquisitions/mergers.
- VIII. Paragraph 8.0 (Standard Terms and Conditions), Subparagraph 8.11.1 is deleted in its entirety and replaced as follows:
 - Should Subrecipient (that is, "Contractor") require additional or replacement personnel after the effective date of this Subaward (that is, "Contract"), Contractor shall give consideration for any such employment openings to participants in County of Los Angeles Department of Public Social Services (DPSS) Greater Avenues for Independence (GAIN) Program or General Relief Opportunity for Work (GROW) Program who meet Contractor's minimum qualifications for the open position. For this purpose, consideration shall mean that Contractor will interview qualified candidates. County will refer GAIN/GROW participants by job category to Contractor. Contractor shall report all job openings with job requirements to:

GAINGROW@dpss.lacounty.gov and BSERVICES@wdacs.lacounty.gov and DPSS will refer qualified GAIN/GROW job candidates.

- IX. "Exhibit B (Budget) Amendment 2 (FY 2018-19 Baseline)" is added, is an addendum to "Exhibit B (Budget)", and is attached hereto and incorporated herein by reference.
- X. "Exhibit C (Mandated Program Services) Amendment 2 (FY 2018-19 Baseline)" is added, is an addendum to "Exhibit C Proposed Program Services (MPS)", and is attached hereto and incorporated herein by reference.
- XI. "Exhibit M (Purchase, Inventory and Disposal Requirements for Fixed and Non-Fixed Assets and Supplies)" is deleted in its entirety and replaced with the attached "Exhibit M (Purchase, Inventory and Disposal Requirements for Fixed Assets, Non-Fixed Assets and Supplies)", which is incorporated herein by reference.
- XII. "Exhibit T (List of Lower Tier Subawards)" is added and is attached hereto and incorporated herein by reference.

All other terms and conditions of the Subaward shall remain in full force and effect.
