SUBJECT: Payment of Invoice No. 100006 – LAZ Parking

RECOMMENDATION:

It is recommended that the Mayor and Council Members approve payment of Invoice No. 100006 to LAZ Parking, for Shuttle services provided for the Taste of Inglewood Big Game Concert Series Festival event, in the amount of \$29,640. (General Fund)

BACKGROUND:

On Market Street, in Downtown Inglewood, the City of Inglewood held its Taste of Inglewood Big Game Concert Series Festival from Thursday, February 10, 2022, through Saturday, February 12, 2022. The Festival Concert Series attracted people from all over the nation to come to Inglewood for the Super Bowl game.

LAZ Parking provides shuttle services to SoFi Stadium for football games, as well as other events that are held at SoFi. They offer shuttle services from several parking lots and parking structures throughout the City. Individuals attending games and events at SoFi are encouraged to use LAZ Shuttle services, which helps to reduce traffic and congestion on days when events occur.

DISCUSSION:

The shuttle service brought riders up to Market and Regent Streets, dropping them off to enjoy the event. Shuttles ran every 15 minutes for pick up and return to the parking location. The shuttle was available from 2:00 p.m. to 10:00 p.m. each day.

LAZ shuttle service serviced over 30,000 event attendees over the 3-day festival period. The shuttle service was an integral part of the event, as many attendees found the service helpful and convenient and contributed to a fun and joyful experience.




