SUBJECT: Payment of Invoice – King Fence Inc.

RECOMMENDATION:

It is recommended that the Mayor and Council Members authorize payment of an invoice submitted by King Fence, Inc. for installation of fencing at Edward Vincent Park, in the amount of \$3,595.95. (General Fund)

BACKGROUND:

Around October 2020, sections of chain-link fencing at Edward Vincent Park were compromised, due to age and condition. This situation was exacerbated when coupled with the COVID pandemic and vandalism by unhoused individuals seeking a secluded place to camp. Related incidents included homeless individuals cutting chain links and removing weakened posts to gain access to certain areas of the park. To secure the impacted areas and deter encampments, portions of the fence needed to be repaired and or newly installed.

DISCUSSION:

King Fence, Inc. removed and disposed of the existing worn out chain link fencing and installed nine gauge galvanized chain link fencing at the perimeter of Vincent Park. However, there is no record of payment for the services provided and, therefore, staff is requesting authorization of payment of the invoice.

Funding in the amount of \$3,595.95 is available under Account Code No. 001-070-7021-44870 (General Fund, PRCS, Park Maintenance - Contract Services).




