Staff report dated February 5, 2019, was presented recommending adoption of resolutions approving and authorizing the execution and delivery of a Joint Exercise of Powers Agreement by and between the City of Inglewood and the Inglewood Housing Authority to create the Inglewood Joint Powers Authority.
