RESOLUTION NO.: 17-124

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA, REPEALING RESOLUTION NO.: 15-04 AND RETRACTING THE LEVEL 1 WATER SUPPLY SHORTAGE CONDITION IN ACCORDANCE WITH SECTION 10-265 OF THE INGLEWOOD MUNICIPAL CODE.

WHEREAS, on January 17, 2014, the Governor issued a proclamation of a state of emergency under the California Emergency Services Act based on drought conditions; and

WHEREAS, on April 25, 2014, the Governor issued a proclamation of a continued state of emergency under the California Emergency Services Act based on continued drought conditions; and

WHEREAS, on October 21, 2014, the City Council, in accordance with Article 19 of Chapter 10, et seq. declared a Level 1 Water supply shortage condition in response to the Governor's mandate to reduce water usage by 25% across the State; and

WHEREAS, the drought conditions that formed the basis of the Governor's emergency mandate no longer exist; and

WHEREAS, water supply conditions have substantially improved in recent years and Northern California and Colorado River Reservoirs at near maximum capacity allowing wholesalers to store water for the first time in at least four years; and

WHEREAS, on May 18, 2016, in response to much improved water supply conditions in California, Governor Brown replaced mandatory percentage-based restrictions with regional "stress tests" ensuring a three-year water supply for continued drought conditions; and

WHEREAS, the current water supply conditions that prompted the implementation of the Level 1 Water Supply shortage stage of the City's Water Conservation Ordinance are no longer applicable due to the adequate availability of water; and

WHEREAS, although water conditions have improved, all residents must continue to conserve water and practice water-wise behaviors in conjunction with the ongoing

conservation requirements of Ordinance number 15-02. NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Inglewood, California does hereby declare: SECTION 1. Resolution No.: 15-04 repealed and authorizes the reinstatement of the Permanent Water Conservation Requirements of Ordinance number 15-02, (10-264 of the Inglewood Municipal Code). SECTION 2. BE IT FURTHER RESOLVED that the City Clerk shall certify to the adoption of this resolution and the same shall be in full force and effect immediately upon adoption.
