I, _____, (the "Undersigned") being over the age of eighteen (18), in consideration of being permitted to participate in the City of Inglewood Parks, Recreation and Community Services Department - Volunteer Program (the "Program") which may include participating in one-day events as well as programs and services (recreational, sports, human services, clerical, parks and other City facilities maintenance) that run over a course of weeks or months, agree to:

1. Waive, discharge, covenant not to sue and release the City of Inglewood, its employees, officers, volunteers, and agents (the "City") from all liability to the Undersigned, his or her heirs, representatives and assigns for any loss, damage or claim therefore on account of injury to the person or property of the Undersigned whether caused by ordinary negligence, act or omission of the City, the direct or indirect transmission or exposure to an INFECTIOUS AGENT including, but not limited to, COVID-19, SARS-CoV-2, and any mutations arising from or relating thereto while the Undersigned is participating in the Program or using City facilities or equipment in connection with participation in the Program.
2. Indemnify and hold harmless the City from all liability, claims, demands, causes of action, charges, expenses, and attorney fees resulting from participation in the Program, whether caused by any act or omission of ordinary negligence of the City, or otherwise.
3. Grant the City and its legal representatives and assigns, the irrevocable and unrestricted right to use and to publish photographs, audios, pictures, slides, movies, or videos (collectively "Electronic Media") of me or my child under 18 years of age, for any legal purpose, in any manner and medium, without compensation from the City and to copyright and alter the same without restriction. I hereby release the City and their legal representatives and assigns from all claims and liability relating to said Electronic Media.

THE UNDERSIGNED UNDERSTANDS THAT THIS DOCUMENT RELIEVES THE CITY OF INGLEWOOD FROM LIABILITY FOR PERSONAL INJURY, WRONGFUL DEATH, AND PROPERTY LOSS AND DAMAGE RESULTING FROM PARTICIPATING IN THE PROGRAM. THE UNDERSIGNED ALSO UNDERSTANDS THAT S/HE HAS GIVEN UP SUBSTANTIAL RIGHTS AND SIGNS VOLUNTARILY. THE FOREGOING RELEASE, WAIVER, AND INDEMNITY ARE INTENDED TO BE AS BROAD AND INCLUSIVE AS PERMITTED BY LAW.
