The following projects will be **EXEMPT** from the fee assignment:

- **Work for which a plumbing, electrical, or mechanical permit is required**
  - **Seismic tie-down projects, installation of shelves replacement**
    - **Installation of pre-fabricated patio enclosures and cover**
  - **Installation of pre-fabricated accessories such as signs or antennas**
    - **Reroofing projects, Installation of swimming pools/ spas**

The State of California requires that 50% of construction and demolition debris from covered projects (described below), and 100% of land-clearing debris (from nonresidential, newly constructed buildings), be diverted from land filling.

**Covered Projects:**

The following projects are subject to construction and demolition (“C&D”) debris diversion requirements:

- All new construction (residential, commercial, and industrial)
- All demolition projects (residential, commercial, and industrial)
- Commercial and industrial additions of greater than or equal to 1,000 square feet
- Commercial and industrial alterations of greater than or equal to \$200,000
- Residential additions and alterations which increase the building’s conditioned area, volume, or size. Applies only to and or within the specific area of addition or alteration.
